

#### **Terms and Conditions**

# 1. Applicability and change of conditions

Unless otherwise agreed in writing, the terms and conditions apply to all offers, agreements, additional and follow-up orders between contractor, Karin Bosveld - Live Your Soul Purpose (KBLYSP, contractor) and client. Deviations from these conditions are only valid if these are expressly agreed in writing.

Karin Bosveld - Live Your Soul Purpose is entitled to change the conditions. Changes to the conditions also apply to existing agreements. KBLYSP will announce changes to the terms and conditions via

http://www.karinbosveld.com. The amended conditions come into effect 2 weeks after announcement, or as much later as stipulated in the announcement.

## 2. Quotations

The offers made by the contractor are without obligation and valid for 30 days, unless otherwise specified. Contractor is only bound to the quotation if the acceptance thereof is confirmed in writing by the other party within 30 days. Prices in the offers are exclusive of VAT (21%), unless otherwise indicated. Offers are based on the information available to the contractor.

#### 3. Agreement

There is an agreement when:

- You sign up for an online or offline training, course, program, seminar, retreat, 1-on-1 coaching or other product via the website, e-mail, skype, by phone or in writing.
- An offer made in writing, verbally or by telephone is accepted.
- You purchase a (digital) product via the website.

### 4. Execution of the agreement

Agreements concluded with me lead to a best efforts obligation for me, not to a result obligation, whereby I am bound by my obligations to comply in such a way as can be expected of me in terms of standards of care and craftsmanship and in terms of standards of the moment of fulfillment.

#### 5. Cancellation

Trainings, courses, workshops, retreats, master classes, VIP days and other events

You must pay these directly via the online payment system when you register, unless otherwise agreed. When an invoice is sent, you must pay 14 days after receipt at the latest.

Cancellation without giving a reason is possible up to 14 days after the purchase (i.e. booking

via website, email or verbal agreement) of a product.

When purchasing a product or service that is delivered within the reflection period of 14 days, you waive the right of withdrawal from the moment the course starts. of the right of withdrawal. An online program starts when the first lesson or module is online and you have received the login details for this. Cancellation is then no longer possible.

The following cancellation conditions apply to retreats:

Cancellation is free of charge up to 8 weeks before the start.

After that, the costs are: 8-6 weeks before the start: 35% of the costs.

6-4 weeks before the start: 60% of the costs. 4-2 weeks before the start: 85% of the costs.

Within 2 weeks: 100% of the costs.

## 1-on-1 coaching

In case of cancellation of a coaching session (live or via skype or zoom) within 5 working days 50% of the invoice amount will be charged. If canceled within 24 hours, you will be charged the full invoice amount. Until 5 working days before the start rescheduling - in consultation – is possible and cancellation is free of charge. In the event of an emergency, I can also change the date of a meeting myself. I will let you know as soon as possible; we will then make a new appointment.

### 6. Payment

Services and products must be paid in advance, unless otherwise agreed. If at the start of the training, intensive, retreat or other form of transmission your payment has not been received, I can refuse your participation. In case of invoicing afterwards, I would like to receive your payment within 7 days after the invoice date. If payment is not made, I can appeal to a collection agency. You must reimburse all judicial and extrajudicial costs that I reasonably have to make if payment is not made.

All amounts stated on the website are exclusive of 21% VAT, unless otherwise stated.

# 7. Replacement or rescheduling

If I am unable to provide training \* due to illness or force majeure, I am free to call in a replacement or to move the training to another date. For 1-on-1 coaching and VIP days I do not look for a replacement, but in case of force majeure I will make a new appointment with you.

#### 8. Change training date

In case of insufficient participation, a training or course date can be postponed or canceled.

<sup>\*</sup> training also includes retreat, intensive or other form of transfer.

## 9. Transferability

Products purchased by you or participation in events, courses, retreats, coaching &c are not transferable to third parties, unless otherwise agreed.

## 10. Conditions of participation

During an event, course, retreat, masterclass, etc., you must adhere to the procedures, instructions and directions from Karin Bosveld or her employees. When a participant does not adhere to or stops following procedures in any way hinders the enjoyable participation of other participants we have the right to deny this participant further access.

## 11. Photography and filming

Sometimes events, courses, retreats, masterclasses, etc. by Karin Bosveld are photographed or filmed for promotional or instructional purposes. Please state in advance if you do not want to be (recognizably) photographed or filmed.

### 12. Program

Karin Bosveld reserves the right to make changes to the programwhen necessary.

## 13. Health and safety

For your safety, you must adhere to all relevant rules and security measures that apply at the location of the particular event.

#### 14. Limited Liability

Travel, trips, accommodation, etc. related to an event of Karin Bosveld that are arranged and undertaken by yourself are not covered by the liability of Karin Bosveld. Neither KBLYSP nor the location can be held liable for loss, theft or damage to personal belongingsother than as a result of our negligence or non-compliance with agreements.

You are liable for damage caused by you to or at the event location.

Nothing in these General Terms and Conditions limits or excludes liability of either party for death or personal injury arising from its negligence, fraud or any other liability that cannot be excluded or limited under applicable law.

# 15. Complaints

If you have a complaint about a service or product provided by me, you can let us know within 10 working days. I'll do my very best to work out a solution with you. If I don't hear back within 10 working days, I assume that you are satisfied.

I am not liable for damage of any kind caused by incorrect or incomplete information. My liability does not exceed the agreed invoice amount for the service or product. My liability for property damage does not exceed the amount that my insurance policy actually covers. If the insurance does not pay, my liability is limited to the agreed invoice amount for the relevant service or product.

My products and services are intended to support and facilitate

personal and spiritual development, and does not replace services and / or treatment of a doctor, psychologist, psychiatrist, or medication. If the client is being treated by a doctor or other care provider, it is the responsibility of the client to notify and to consult about following coaching or training with me.

I am not liable for the consequences of discontinuation of treatment or medication.
